Gloucestershire County Council has made an order to temporarily restrict under the Road Traffic Regulation Act 1984 (as amended) the roads as shown in the schedules below:-

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for Various Roads within Cheltenham and Tewkesbury Boroughs ("the Roads") is satisfied that use of part of the Roads should be restricted because of the likelihood of danger to the public or of serious damage to them.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Roads as shown in the Schedules below:-

SCHEDULE 7 - SUSPENDED ORDERS

Articles 5 and 7 of The Borough of Cheltenham (Promenade) (Prohibition of Buses and Pedal Cycles) Order 1991 [variation to the Borough of Cheltenham (Central Area) (Pedestrian Priority) Order 1987] [and any other Order imposing a restriction on the Roads or diversion routes which are adversely affected by this Order are hereby suspended for the duration of the works]

2. In this Order -

"Cheltenham Racecourse Major Event (CRME) "means an event held at Cheltenham Racecourse and in respect of which the Jockey Club, having consulted with the Council, consider it likely that the gate at that event will exceed 15,000 people, and has given at least 28 days notice to the Council that any such event will be so designated.

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988

"Vehicle" means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order

- Nothing in Article 1 shall render it unlawful for a Vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads
- 4. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads
- 5. The Roads fall in the Battledown Ward, Charlton Park Ward, College Ward, Pittville Ward, Swindon Village Ward, Cleeve Grange Ward, Cleeve West and Cleeve Hill Wards, Prestbury Parish, Bishops Cleeve Parish, Swindon and Southam Parishes in the Cheltenham and Tewkesbury Boroughs in the County of Gloucestershire
- 6. This Order shall come into operation on the 12th March 2019 and shall continue in force for a period not exceeding eighteen months
- 7. This Order may be cited as "Gloucestershire County Council, Temporary Restrictions along Various Roads within Battledown, Charlton Park, College, Pittville, Prestbury, Swindon Village, Cleeve Grange, Cleeve West and Cleeve Hill Wards, Prestbury, Bishops Cleeve, Swindon and Southam Parishes, Cheltenham and Tewkesbury Boroughs, Order 2019"
- 8. The Restrictions will only be in force during a CRME and shall only operate when indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
