NOTICE is hereby given that Gloucestershire County Council intend to make an Order under the Road Traffic Regulation Act 1984, the effect of which is to vary the Gloucestershire County Council (The Borough of Cheltenham) (Prohibition and Restriction of Waiting and Loading and Parking Places) Amendment (Consolidation) Order 2008 ("the Consolidation Order") to amend Schedules 2 and 3 to create a new Zone R in Cheltenham. This is an administrative process to determine who may be entitled to parking permits within the new Zone R and to which roads the permits apply. This is aimed at improving the amenity of the area close to Cheltenham Racecourse for local residents/businesses by managing parking on major event days at the racecourse ONLY and giving a better chance for them to park in the neighbourhood during these events.

- The Consolidation Order will be varied by the attachment thereto of the Variation of Gloucestershire County Council (The Borough of Cheltenham) (Prohibition and Restriction of Waiting and Loading and Parking Places) Amendment (Consolidation) Order 2008 (By Amending Schedules 2 and 3 to Create Zone R, Racecourse, Cheltenham) Order 2016 ("the Zone R Order") (which identifies the amendments that need to be made to the Consolidation Order).
- This Zone R Order shall come into operation within 14 days of it being made and may be cited as the Variation of Gloucestershire County Council (The Borough of Cheltenham) (Prohibition and Restriction of Waiting and Loading and Parking Places) Amendment (Consolidation) Order 2008 (By Amending Schedules 2 and 3 to Create Zone R, Racecourse, Cheltenham) Order 2016.

The lengths of roads fall within the Borough of Cheltenham in the County of Gloucestershire.
